NOTES:

1. If an item does not clearly fit into one of the above categories, the principal and superintendent shall confer to review the incident and make a recommendation for the action to be taken.
2. In categories where a range of consequences exists, the consequence is at the discretion of the administrator.
3. For all EEN students, if the Manifestation Determination Hearing finds that the behavior is not a manifestation of the handicapping condition, the consequence will be as indicated on the appropriate line.
4. Law enforcement personnel will secure confiscated weapons. Under no circumstances will a confiscated weapon be returned to a student.
5. Consequences will be progressive.
